# A. US-23 SIDEWALK PROPOSAL-WADE TRIM

Discussion was held regarding the sidewalk proposal on Main Street. Motion by Council Member Reno, seconded by Council Member Macaulay to waive the 50/50 requirements for businesses in the project area. All yeas, motion carried.

Motion by Council Member Macaulay, seconded by Council Member Reno, to approve the contract with Wade Trim as presented for the engineering of US-Sidewalk Project and to authorize the City Manager/Mayor to sign. All yeas, motion carried.

# B. FOCO ROAD PROPERTY

Discussion was held regarding the City's property on Foco Road. No action was taken.

# C. BUILDING AUTHORITY APPOINTMENTS

Discussion was held regarding the Building Authority appointments. Motion by Council Member Macaulay, seconded by Council Member Ireland to appoint Rick Weishuhn to a one year term to the City of Standish Building Authority, Mike Calery to a two year term to the City of Standish Building Authority and Tom Goike to a three year term to the City of Standish Building Authority, effective immediately. All yeas, motion carried.

# D. DISPOSITION OF 1987 MAC DUMP TRUCK

Discussion was held regarding the trade of the City's salt truck as part of payment for the repair of the 1987 MAC truck.

Motion by Council member Tunney, seconded by Council Member Reno to put the salt truck up for bid. All yeas, motion carried.

#### E. POLICE DEPT. RESERVE PROGRAM

Discussion was held regarding the Police Department Reserve program that Chief Christian would like to have here at the City of Standish. There would be two Officers who will ride along with the Chief and they will be MCOLES certified. There would be no cost to the City. Motion by Council Member Reno, seconded by Council Member Tunney to approve the Police Department Reserve Program as presented. All yeas, motion carried.

#### F. BILLS TO BE APPROVED

Discussion was held regarding three bills, two luncheons with the Federal Bureau of Prisons, one at the Pine River Golf Course for \$171.65 and one at Chan's Chinese Restaurant for \$33.66 and the last one was for the Tree Removal on James and Pine Street.
